If you are considering a bequest

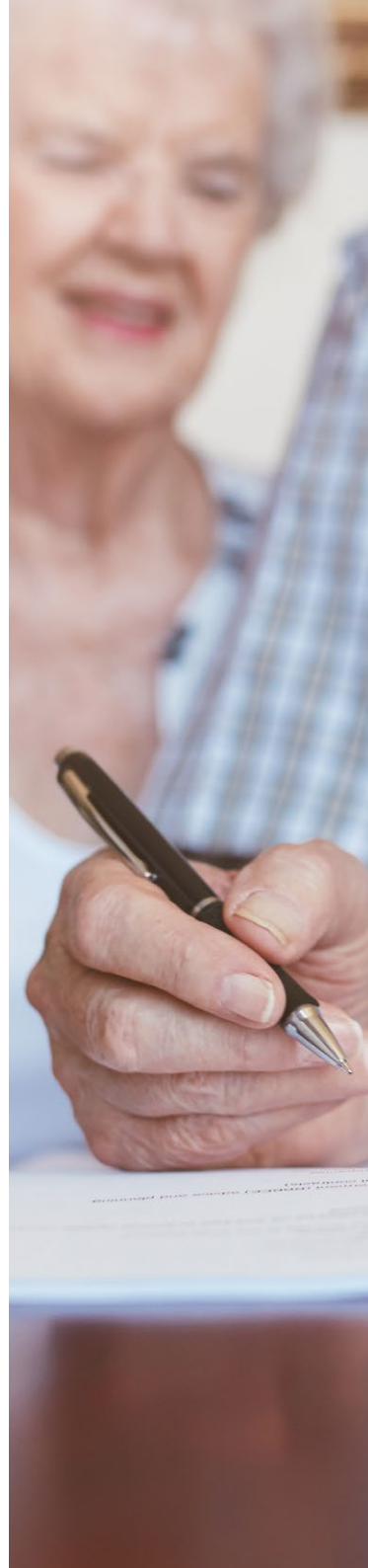
If you want to make a bequest, please seek legal advice to help draft your will.

To help you in the preparation of a bequest, may we advise the following wording:

I give, devise and bequeath to Masonic Care Tasmania (ABN 21 590 239 241) free from and clear of all duties (death, estate, succession or otherwise, State or Federal) payable upon reason or in consequence of my death, the following [insert details of bequest here].

I declare that (a) the receipt issued by Masonic Care Tasmania (ABN 21 590 239 241) shall constitute a full and complete discharge to my executors who shall be bound to see or enquire into the application of such legacy and (b) in making this bequest I have a general charitable intention.
